BYLAW NO. 1-01

A BYLAW to provide for entering into an agreement with another Municipality for the Furnishing of Fire-Fighting Services and Fire-Fighting Equipment Beyond Our Boundaries.

THE COUNCIL OF THE RURAL MUNICIPALITY OF VISCOUNT NO. 341, in the Province of Saskatchewan, enacts as follows:

- 1. The Rural Municipality of Viscount No. 341 is hereby authorized to enter into the agreement attached hereto and forming part of this bylaw, which is to be identified as EXHIBIT "A", with the Rural Municipality of Wolverine No. 340 for the purpose of the furnishing of fire-fighting services and fire-fighting equipment beyond the Municipal boundary.
- 2. The Reeve and Administrator of the Rural Municipality of Viscount No. 341 are hereby authorized to sign and execute the attached agreement identified as **EXHIBIT** "A".
- 3. This bylaw shall come into force on the 1st day of January, 2001.

- 1. The parties to this agreement acknowledge that the parties have a common interest in extinguishing fires and therefore agree to enter into a joint agreement to manage fire fighting services to areas of the Rural Municipality of Wolverine No. 340.
- 2. The Rural Municipality of Viscount No. 341 hereby agrees to provide fire fighting services to the following area of the Rural Municipality of Wolverine No. 340:

Sections 5 to 8, inclusive in Township 34, Range 24;

NW 1/4 of Section 14 in Township 34, Range 24;

N 1/2 of Section 15 in Township 34, Range 24;

W 1/2 of the SE Section 15 in Township 34, Range 24;

SW 1/4 of Section 15 in Township 34, Range 24

Sections 16 to 23, inclusive in Township 34, Range 24;

W 1/2 of Section 24 in Township 34, Range 24;

W 1/2 of Section 25 in Township 34, Range 24;

Sections 26 to 35, inclusive in Township 34, Range 24;

W 1/2 of Section 36 in Township 34, Range 24;

Sections 1 to 12 inclusive in Township 35, Range 24;

All West of the Second Meridian and located in the Rural Municipality of Wolverine No. 340.

- 3. The Rural Municipality of Wolverine No. 340 hereby agrees to pay an annual fee of \$1,500.00 to the Rural Municipality of Viscount No. 341 for providing fire protection services.
- 4. The Rural Municipality of Viscount No. 341 hereby agrees that any costs incurred due to the damage of the fire-fighting equipment while being used within the above-mentioned boundaries will be the responsibility of their municipality.
- 5. It is understood that either party hereto may terminate this agreement upon three (3) months written notice to such effect delivered to the other party.
