

**RURAL MUNICIPALITY OF VISCOUNT NO. 341  
BYLAW NO. 2023-03**


**A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF  
WATER AND TO FIX THE RATES TO BE CHARGED FOR THE USE OF THE SEWER  
SYSTEM AND CAPITAL INFRASTRUCTURE**

**THE COUNCIL OF THE RURAL MUNICIPALITY OF VISCOUNT NO. 341**, in the Province of Saskatchewan, enacts as follows:

The Council of the Rural Municipality of Viscount in the Province of Saskatchewan enacts as follows:

1. This bylaw may be cited as the "Plunkett Utilities Bylaw".
2. Any person requiring water and/or sewer service in the Special Services Area of Plunkett shall make application to the RM of Viscount. The application shall be in a form determined by administration requiring any information deemed necessary for the provision of water and sewer service. Such form shall be accompanied by the payment of a non-refundable administrative connection fee in accordance with Schedule "A" attached.
3. The charges to be paid by the consumer whose water service has been turned on, or whose premises drains, or is by bylaw required to be drained, into the sewer, shall be those set out in Schedule "A" attached. For all services that have been turned on at the curbstop, the minimums shall be payable in every case, whether or not any water is consumed.
4. Any person wishing to turn off or disconnect their water account/service shall provide notification of such request in writing to the RM Office. Persons whose water account is disconnected and/or connected, even if temporarily, shall pay the non-refundable administrative fee(s) as set out in Schedule "A".
5. Accounts for water service and/or sewer service shall cover a period of three successive months, and shall be rendered on or before the fifteenth day of the month next following such period.
6. If the applicable user is no connected to the Special Services Area sewer structure, they will not be subject to the sewer charges and rates.
7. Accounts shall be paid within a period of thirty (30) days from the date on which such accounts are rendered.
8. When the utility service is cut off due to a delinquent bill, it shall not be turned on until all arrears have been paid, together with the non-refundable administrative fee as set out in Schedule "A".
9. Accounts remaining unpaid after one hundred and twenty (120) days from the original date of billing will be handled under section 369 of "The Municipalities Act".
10. Bylaw #2021-15, adopted November 12, 2021 by the former Village of Plunkett council, is hereby repealed.
11. The rates and charges contained in this bylaw shall come into force and take effect on the day of approval being issued by the Saskatchewan Municipal Board, a copy of such approval being attached to this bylaw once received, or July 1, 2023, whichever is later.
