2026 MUNICIPAL ELECTION

*A municipal election will be held in **November 2026** for Councillors representing Divisions 2, 4 and 6.*

ROADS & PUBLIC WORKS

Road grading, graveling, culvert maintenance, vegetation control, snow removal and equipment maintenance remain major priorities for the rm.

Road work is scheduled according to road conditions, safety, weather, equipment availability and available resources.

Custom Work Agreement – Required

A Custom Work Agreement must be completed and approved before any custom work is performed by the RM. A copy of the Custom Work Agreement is available on the RM website under Forms & Permits.

NEW RM SHOP

The rm's new shop is an important investment in municipal infrastructure and public works operations.

The facility will provide improved space for equipment, maintenance and municipal operations.
